Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water. Take victim immediately to hospital. Consult a doctor.

Eye contact: Bathe the eye with running water for 15 minutes. Consult a doctor.

Section 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Personal precautions: Do not attempt to take action without suitable protective clothing - see section 8 of SDS. Turn leaking containers leak-side up to prevent the escape of liquid. Refer to section 8 of SDS for personal protection details. Evacuate the area immediately. Wear respiratory protection. Avoid breathing vapours, mist or gas. Ensure adequate ventilation. 8.2. Exposure controls
