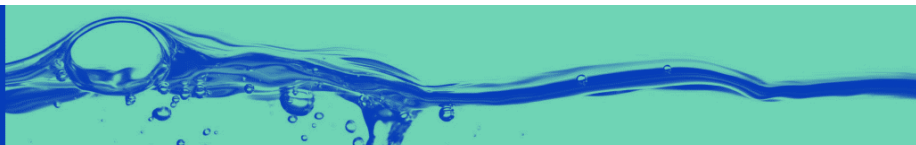

#### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>Inhalation</b>	Unlikely route of exposure as the product does not contain volatile substances.
<b>Ingestion</b>	Rinse mouth thoroughly with water. Do not induce vomiting. Give a few small glasses of water or milk to drink. Keep affected person under observation. Get medical attention if any discomfort continues.
<b>Skin contact</b>	Remove contaminated clothing and rinse skin thoroughly with water. Get medical attention if symptoms are severe or persist after washing.
<b>Eye contact</b>	Rinse cautiously with water for several minutes. Remove any contact lenses and open eyelids wide apart. Continue to rinse. Get medical attention if symptoms are severe or persist after washing.

#### 4.2. Most important symptoms and effects, both acute and delayed

<b>Inhalation</b>	Unlikely to be hazardous by inhalation because of the low vapour pressure of the product at ambient temperature.
<b>Ingestion</b>	Harmful if swallowed. May cause chemical burns in mouth, oesophagus and stomach.
<b>Skin contact</b>	May cause serious chemical burns to the skin.
<b>Eye contact</b>	Causes serious eye damage.

#### 4.3. Indication of any immediate medical attention and special treatment needed

<b>Notes for the doctor</b>	No specific recommendations.
<b>Specific treatments</b>	Treat symptomatically.

### SECTION 5: Firefighting measures

#### 5.1. Extinguishing media
